## STEWARDS' DECISION

**From:** The Stewards

**To:** GetSpeed

The Stewards, having received a report from the Race Director, summoned and heard from the competitor's representative, have considered the following matter and determine the following:

**No. / Driver:** 6 - Karol Basz

**Competitor:** GetSpeed

**Time:** 10:33

**Session:** Free Practice 1

**Fact:** Exceeded the speed limit in the pit lane with a speed of 66.6 km/h

**Offence:** Breach of Article 27.4 and 28.11 of the GT World Challenge Europe powered by AWS 2026 Sporting Regulations, Article 12.2.1.j of the FIA International Sporting Code and Chapter IV Article 5c) of Appendix L to the Code

**Decision:** Fine of 850 EUR + 1 BWP

**Reason:** Timekeeping data shows that car 6 circulated in the pit lane at a speed of 66.6 kph, thereby exceeding the 50 kph pit lane speed limit. The Stewards determine that this is a breach of Article 28.11 of the above regulations and impose the penalty specified in accordance with that Article.
