STEWARDS' DECISION

To: Car Collection Motorsport

The Stewards, having received a report from the Race Director and reviewed Timekeeping evidences, have considered the following matter and determine the following:

No. / Driver: 8 - Reinhold Krahn

Competitor: Car Collection Motorsport

Time: 21:21

Session: Qualifying 2

Fact: Exceeded the speed limit (80 km/h) at Sector 2 under Red Flag conditions

Offence: Breach of Article 27.1 and 36.1 of the GT World Challenge Europe powered by AWS 2026 Sporting Regulations and Article 2.5.4.1 b) of Appendix H to the Code

Decision: Drop of 5 places on the grid next race and 1 BWP

Reason: Timekeeping Data examined. During the red flag procedure, Car 8 was observed traveling at a speed of 130.8 km/h.

Having examined the matter extensively, the Stewards concluded that Car 8 surpassed the permitted speed limit by 50.8 km/h during a red flag procedure, failing to adhere to the requirements outlined in article 36.1 of the GT World Challenge Europe powered by AWS 2026 Sporting Regulations. As a result, the Stewards decide to impose a penalty of a five-place grid drop for the next race, along with the addition of one behavior warning point.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code, within the applicable time limits.
